



**2025 VOLUNTEER EMERGENCY SERVICES GRANT PROGRAM**

# REQUEST FOR PROPOSAL

## 1. OVERVIEW

The Copper Shores Community Health Foundation’s (CSCHF) mission is to positively influence a healthful community through enhanced philanthropy and collaboration.

Over the past year, several requests have been made to support volunteer emergency services throughout the four-county (Baraga, Houghton, Keweenaw, and Ontonagon) community. CSCHF recognizes the important role these organizations play in our community’s ability to build safer communities for our citizens.

These grants intend to support projects that will have an impact on community health and wellness while addressing the systemic health needs and risk factors of the broader community. Further, it is hoped and desired that proposals seeking funding will have identified key components to support sustainability and/or systems change to ensure ongoing delivery of services to meet community needs.

This request for proposal is specifically addressing CSCHF’s long-term sustainability goals of building safer communities.

All emergency services grant requests must align with the Copper Shores Community Health Foundation’s mission.

## 3. ELIGIBILITY

To be eligible to apply for a grant under this program, the applicant must:

- Be recognized by the Internal Revenue Service as a 501(c)(3) non-profit organization; or a local unit of government or a public institution of education; (note: Applicants must be current with their IRS tax-exempt organization determination and have a current License to Solicit Charitable Contributions as required, unless exempt under MCL 400.283.)
- Be domiciled in Baraga, Houghton, Keweenaw, or Ontonagon counties of Michigan, and serve the citizens of the same;

- Have filed their most recent 990, 990-EX or 990-N filing and;
- Have a certified financial audit or reviewed financial statements as required by state law; (Note: for all nonprofits with annual gross receipts of \$250K or less, CSCHF requests CPA prepared compiled financial statements for their most recently completed fiscal year);
- Have adequate and demonstrated organizational capacity to successfully execute the proposed grant, including all reporting requirements.

**TO BE CONSIDERED FOR AN EMERGENCY SERVICE GRANT, A PROPOSAL MUST:**

- The department pays 50 percent of the costs, up to the allocation amount;
- The department must be registered with the State Fire Marshall's office and file all incident reports; and,
- Identify why the funding request is needed and how it will enhance access to services, programs, or activities that otherwise would not be possible. This grant is intended to be for firefighting equipment and personal protective gear, not for mobile equipment (trucks) and buildings.

**APPLICATION EVALUATION CRITERIA:**

The Copper Shores Community Health Foundation will evaluate each application on the following criteria:

- Does the proposal have goals/objectives that advance CSCHF's mission?
- Does the proposal identify an unmet community need/health risk?
- Does the proposal have measurable goals and objectives?
- Does the proposal have a budget that identifies and covers all necessary expenditures?
- Does the proposal identify a plan for sustainability?
- Is there potential to achieve significant long-term impact by implementing effective models or supporting needed innovation;
- Does the proposal demonstrate the use of industry standards, best practices, or science-based methodologies as appropriate;
- Does the proposal demonstrate collaboration, including leveraging other resources; and
- Does the proposal have the potential to be replicated in other settings, including opportunities for learning, knowledge dissemination, and to inform public-policy?

The Copper Shores Community Health Foundation Grants Committee and the Board of Directors have sole responsibility for all grant decisions.

**APPLICATIONS EXCLUDED FROM FUNDING CONSIDERATION:**

- Repayment or securing loans;
- Activities supporting religious organizations for religious purposes;
- Activities supporting political organizations for political purposes;
- Organizations that practice exclusivity based on race, color, religion, sexual orientation, gender, national origin, age, marital or veteran status;
- Proposals in which granted-funds will be used to maintain existing program(s) or solely fill a budget-gap for current services, and;
- For-profit businesses.

**4. GRANT AMOUNT**

Copper Shores Community Health Foundation expects to award up to \$50,000.00 towards successful proposals under this round of funding. There is no minimum grant amount and the maximum amount awarded per grant under this RFP will be \$5,000.00.

- Set specific outcomes for the proposed program, monitor progress toward achieving expected outcomes, and report progress on a regular basis to the Copper Shores Community Health Foundation;
- Participate in any data collection and evaluation activities conducted by the Copper Shores Community Health Foundation and/or its partners; and
- Participate in grantee gatherings and other activities that support dissemination of knowledge.
